- b. Wish List for hall improvements, tabled
- c. Weed Control, a notice was received from the County and Gene Campbell has mowed the land addressed in the notice.
- d. Information regarding using Equs as the supplier for the hall. There an issue re the pole so Fortis has cancelled. Discussion is still on going re this issue, as per Gene Campbell.
- e. Hall Insurance, Suzanne Merrilles, has advised that at the present time the county is still set up to share the insurance costs at the 50% value. If this holds that would leave the community paying \$1500. The county is still processing information on how payment will take place, and will advise as soon as a decision has been made.
- f. Suzanne Merrilles also advised that Capital Grants/Matching grants are still available at this time. Submit proposal by June 2019, submitted to council September of 2019, for use in 2020.
- g. Harvest supper prices will remain at \$16 for adults, \$8 for ages 7 to 16, no charge for 6 and under.

- i. Chris Giezen will send out a general news letter updating all on upcoming events and changes to format for the meal at the Jamborees. Chris Giezen was allotted a budget of \$180 for the above.
