JAMBOREE –Upcoming April 13, Menu: Chili, salad, egg buns, dessert. Pat will try and get volunteers. Dan will sell 50/50, Esten will try and help. Some discussion again about changing to an afternoon format in the fall. Gene will talk to Elmer to get his opinion from the musicians point of view. Also mentioned that the cost of \$150 for the musicians is really cutting into our already small profits. Esten asked if there would be a different admission cost for people that do not want the supper. It was agreed again that there will be no discount for this. All attendees will pay the same price. \$12 regular, \$6 musicians.

March Jamboree had 42 attendees, 13 musicians, 6 Volunteers.

It can be a big issue for halls on their own well. Pat asked that we replace and repair both washrooms faucets and urinal leaks. A motion to spend \$630 to hire Jeff's Plumbing to do this job was made by Pat, seconded by Gene, Passed. Gene will contact Jeff.
